- Food Vendor Load-In: Saturday, November 7 | 10:00 AM – 12:30 PM. All vehicles in final position by 12:30 PM.
- Event Hours: 1:00 PM – Evening. Must remain open for the duration unless sold out.
- Load-Out: Begins when event concludes. All equipment cleared by 9:00 PM.
- Waste & Grease Disposal: Vendors responsible for proper disposal. Do NOT dump on park grounds.

FOOD VENDOR RULES & GUIDELINES

- All food must comply with Georgia Department of Public Health rules and the Georgia Food Code.
- Maintain proper temperatures: hot foods $\geq 135^{\circ}\text{F}$, cold foods $\leq 41^{\circ}\text{F}$.
- At least one person with valid ServSafe certification present at all times.
- Vendors responsible for collecting and remitting Georgia sales tax.
- Menu items and pricing must be clearly displayed.
- GTF reserves the right to inspect and shut down any vendor in violation.
- Generators must be properly grounded and safely positioned.
- GTF is not responsible for theft, loss, or damage to vendor property.
- By attending, you consent to being photographed or filmed for GTF promotional use.
